- 4. Category Certificate ,if any belonging to SC ,ST ,Handicapped &Ex-serviceman
- 5. Two Photographs duly attested by Gazetted officer should be pasted on application form

#### Criteria for Admission

- 1. The candidate must be permanent resident of Jammu & Kashmir State.
- 2. The minimum age of the candidate applying for admission is 14 years. However, there is no upper age limit to apply for admission in any of the trades.
- 3. The candidate must possess minimum Educational Qualification prescribed for the desired trade/courses.
- 4. The selection shall be made on the basis of academic merit obtained by the applicants in their qualifying examination based on the minimum qualification prescribed for the particular trade.
- 5. Preference shall be given to the women candidates

- ➤ The Trainees admitted shall be provided Financial Assistance up **Rs.2000**/-(two thousand only) per month to meet their to and fro transport expenses etc. during the training course.
- > The trainees shall be taken to different locations for On-the-job training. The cost of such visits shall be borne by the Department.
- After the successful completion of training courses ,the trainees shall have to appear in the prescribed examination and the Certificates shall be awarded by the State Council for Vocational Training(SCVT)
