In pursuance to Directorate of Skill Development J&K's Admission Notice issued under endorsement No. DSD/401/TRGS/2024/4785-4875 Dated: 28-05-2024, Online applications are invited from the desirous candidates for seeking admission in Govt. ITI Kathua for the academic session 2024-25-26 to various Engineering/Non-Engineering Trades having duration of Two years/One year/Six months for free & Self- finance/IMC seats being run under NCVT/SCVT Schemes and commencing from 2<sup>nd</sup> September 2024 for which the forms can be uploaded from 1<sup>st</sup> of June 2024.

The desirous candidates having minimum age of 14 years as on 1<sup>st</sup> June 2024 with no upper age bar have to fill up the admission forms available online at ITI admission link (<https://itiadmissions.jkdsd.in>) present on the official website of Directorate of Skill development J&K i.e. [www.jkdsd.in](http://www.jkdsd.in).

The last date for applying online is up to 21<sup>st</sup> June 2024. The candidates have to fill up the complete detail which include basic details like name, parentage, qualification etc. online in the portal and have to upload the following documents:-

1. Marks Certificate of Qualifying examination.
2. Passport size photograph
3. Date of birth Certificate preferably 10<sup>th</sup> / 8<sup>th</sup> class Marks Card
4. Category Certificate (SC/ST/Ex-serviceman/Physically Handicapped/EWS) if any
5. Adhar Card.
6. Domicile certificate should be produced at the time of admission in ITI.

The candidates after finalizing the profile and application online will be required to deposit the print out of the system generated application completed in all respects along with self attested photocopies of above-mentioned required documents uploaded on the portal and deposit the prescribed fee of **Rs100/- (one hundred only) per three (03) trades** against proper cash receipt from **Govt.ITI Kathua**.

**IMPORTANT NOTE:**

1. The applying candidates **has to submit print out of system generated application along with requisite self-attested documents at Govt.ITI Kathua.**
2. The candidates shall deposit the fee @ **Rs100/- (one hundred only)** per three trades at GOVT.ITI Kathua against a proper cash receipt.
3. Selection will be made purely on the basis of **academic Merit** in the qualifying examination prescribed for each trade (both for Free & Self finance Seats)
4. On successful completion of training in trades affiliated under NCVT/SCVT Scheme, Certificates will be awarded by the National /State Council for Vocational Education & Training.
5. Candidates, who have already undergone training in any of the trades of ITIs, can apply for admission in another trade two years after completion of previous training course. However, for the ensuing academic session their admission is considered in any of the trades having poor response.
6. **Aspirants should ensure to maintained unique mobile no.& email address (in case of selection), till completion of course and received the certificated, as change is not permitted later.**
